I. ACTION ON ORDINANCES, RESOLUTIONS, SUBDIVISIONS AND LAND DEVELOPMENT PLANS

- 1. Susquehanna Union Green (Phase 1) A Final Land Development Plan for the purpose of depicting the areas for green space, landscaping, sidewalks, street trees, stormwater management area, walking trails, and interior street layout. The property contains 58.07 acres and is zoned TND-1, Traditional Neighborhood Zoning 1. The Plan and associated Design Guidelines were recommended for approval by the Planning Commission with the following condition:
 - 1) Address all remaining comments provided by the Township Staff, the Township Engineer, TCA, Inc., the Design Review Committee, and the Dauphin County Planning Commission. (Ward 9)
- 2. <u>Elise Juers</u> A Preliminary/Final Subdivision Plan for the purpose of a lot line adjustment, transferring ownership of approximately 5,300 square feet from 407 Davis Street to 411 Davis Street. The properties each contain an existing single family dwelling and are located in the R-2, Medium Density Residential Zoning District. The Plan was recommended for approval by the Planning Commission contingent on the approval of the following waivers:
 - 1) 22-404 Preliminary Plan Procedures.
 - 2) 22-1104 Connection to Public Sewer. Sewer and Water Systems (not §18-202) with the condition that this request is reviewed by the Township Authority and a recommendation is provided to the Board of Commissioners.
 - 3) 22-1106 Curbing Requirements A Note shall be placed on the Plan that within six months of notification from Susquehanna Township a curb shall be installed.
 - 4) 22-1107 Sidewalk Requirements A Note shall be placed on the Plan that within six months of notification from Susquehanna Township a sidewalk shall be installed.

The Planning Commission attached the following condition for approval of the Plan:

1) All comments provided by Township Staff, the Township Engineer, and the Dauphin County Planning Commission are addressed. (Ward 6)
