# 11. <u>CAPITOL PRESERVATION COMMITTEE STORAGE FACILITY</u> – A

Preliminary/Final Land Development Plan for the purpose of constructing a 17,200 square foot building with 6,000 square feet of future building expansion. The property is located in the C, Conservation Zoning District and will be utilizing 2.24 acres of the former State Hospital Grounds. The Plan was recommended for approval by the Planning Commission contingent on the approval of the following waiver:

- 8) Address all remaining comments provided by Township Staff, the Township Engineer and Dauphin County Planning Commission. (Ward 3)
