- 3. **BOULDER RIDGE LOTS 17 & 18** A Final Subdivision Plan for the purpose of consolidating two existing lots (17 & 18) into one new single lot between 1873 and 1891 Mountainview Road. The property contains 1.66 acres and is located in the R-1, Low Density Residential Zoning District. The Plan was recommended for approval by the Planning Commission contingent on the approval of the following waivers:

The property contains 4.59 acres and is located in the R-4, Residential Urban District. The Plan was recommended for approval by the Planning Commission contingent on the approval of the following waivers:
 - 1) §22-404 Preliminary Plan Procedure
 - 2) §22-1107 Partial sidewalk with the condition that a contribution is provided to the Township in an amount equal to or approaching the cost of the sidewalk to the Township for future sidewalk projects within the Township.
