- 1. <u>Ordinance 18-01</u> An Ordinance establishing standards, regulations and districts in which uses permitted under the Medical Marijuana Act are permitted.
- 2. <u>Ordinance 18-02</u> An Ordinance amending Section 2008 of the Zoning Ordinance to add new use regulations for multiple family dwellings.
- 3. Ordinance 18-03 An Ordinance prohibiting parking on both sides of North 32nd Street from Walnut Street to Swartz Street.
- 4. **Resolution 18-R-02** A Resolution re-affirming the Township's renewal of the Emergency Operations Plan of Dauphin County.

There will be no construction or improvements proposed with this Plan. The lots are located in the R-1 Zoning District and are on the East side of Fargreen Road, South of Lakeside Drive. The Plan was recommended for approval by the Planning Commission contingent upon the approval of the following waiver:
 - 1) Waive the Preliminary Plan requirement.
 - The Planning Commission also attached the following condition for approval of the Plan:
 - 1) Provide an executed shared driveway agreement setting forth, at minimum, maintenance requirements, snow removal obligations, decision marking for the driveway and funding, and allowing future access to all four (4) proposed lots via the existing shared access drive. Deeds for each of the four (4) lots shall reference the agreement and approved Subdivision Plan.
 - 2) Addressing all comments provided in the Township Staff Report dated 11/27/17 and updated 1/5/18. (Ward 8)
- 6. <u>SUNFLOWER FIELDS</u> A Request to reduce the Site Improvement Guarantee at Sunflower Fields from \$33,105.60 to \$0.00. The Township Engineer reviewed the request and recommended approval. (Ward 9)
- 7. **STURBRIDGE PHASE II** A Request to reduce the Site Improvement Guarantee at Sturbridge Phase II from \$25,547.50 to \$12,485.00. The Township Engineer reviewed the request and recommended approval. (Ward 9)
- 8. ESTATES AT MARGARET'S GROVE PHASE I A Request to reduce the Maintenance Guarantee at Estates at Margaret's Grove Phase I from \$86,180.00 to \$30,000.00. The Township Engineer reviewed the request and recommended approval. (Ward 2)
