

# **Stormwater Utility Fee Coming In 2020**



Like water, federal mandates flow downhill and leave the municipalities at the bottom to handle the problem. The U.S. Environmental Protection Agency enforces strict regulations on polluted stormwater, requiring the Township to show significant progress towards eliminating sediment from Paxton Creek and the Susquehanna River over the next five years. While the Township is partnering with our adjacent communities and PennDOT to implement stream restoration projects to meet these mandates, the cost is still significant.

In addition to the federal requirements, the Township is also dealing with an aging stormwater system. Like sewer pipes, problems with stormwater infrastructure are often unseen until something detrimental occurs. Currently, the cost of repairs to stormwater damage comes from the General Budget, competing with other traditional services provided by the Township such as police, public works, and recreation. In order to

provide a dedicated source of funding, and to increase efficiencies in operation, Susquehanna Township is proposing to transition its stormwater program to the Susquehanna Township Authority (STA). Along with this transition, a stormwater management fee will be implemented to cover the cost of infrastructure repairs and federal mandates. The established fee will allow the STA to equitably distribute the costs of stormwater management services to properties within the community based upon impervious surface and the amount of stormwater runoff from each property. While the exact fee is still being determined, it is anticipated that approximately 80% of property owners will pay an average

of \$10 or less per month. The fee will be billed through the STA. Once established, all revenue collected will be used solely for the operation, management, and improvement of STA's stormwater facilities and our local waterways. More information is available at www.susquehannatwp.com/stormwater.



# **Building Codes and Permits**

Thinking of remodeling or adding an addition to your home? The Susquehanna Township Community Development Department can help you navigate your way through.



### Steps for applying for a permit:

### 1. Determine if the project requires a permit:

Permits are not required for: painting, installing cabinets, flooring, installing new siding material, gutters, downspouts, replacement windows/ doors (in the same opening if the framing is not altered), installation of additional rolled or batt insulation, replacement of existing electrical devices with approved devices, communication wiring and/or wireless devices, repairs to plumbing leaks not requiring structural changes, replacing an existing faucet or sink, clearances of stoppages and replacement of existing appliances.

### 2. If a permit(s) is required, things to consider:

The type of project determines whether approval is required under the Building Code, Zoning Ordinance, Health Code or all three. Township staff should be consulted in the planning stage to determine the permit requirements.

Projects that do not require building permits may require zoning permits. These projects would include fences, certain accessory structures under a certain size, new or expanded driveways, gazebos, etc.

Some projects may require separate electrical and plumbing permits.

A permit to convert from one heating source to another requires a permit. The manufacturer's installation and operation specifications must be submitted with the permit application.

The installation of solar panels on a roof requires a structural engineer to provide verification that the roof can support said additional loading. Electrical plans are required as well.

Please take note that the State Legislature has adopted the 2015 Codes with amendments on October 1, 2018 to the Uniform Construction Code (UCC).Information can be found on the Labor and Industry website www.dli.state.pa.us under the Uniform Construction Code section.

# 3. Obtain the applicable permit application(s) at the Township Building or online at: www.susquehannatwp.com.

# 4. Submit a completed application to the Township Office.

A completed application includes two sets of complete plans (Residential plans must be a minimum of 11" x 17" in size) including specifications and a plot (site) plan.

# 5. Application will be reviewed by Township Staff. Reviews can take up to 15 business days, so plan accordingly.

Projects may also require approval under provisions of other Township Ordinances and State requirements.

Residential plan review and inspections (except for electrical) are performed by the Building and Zoning Office. Certified Third-party Inspection Agencies perform electrical plan review and inspections.

Projects requiring variances or special exceptions from the Zoning Hearing Board must receive approval.

Fees are determined based on the total construction cost of a project. The Township determines the fees.

NOTE: If other approvals are required, these are separate from the building permit review and should be taken into consideration when planning a project. These approvals must be in place prior to submission. In most cases, all approvals must be obtained in order for building, electrical, and plumbing permits to be issued for a project.

### 6. Permit is issued

The Township will contact you when your permit is ready to be picked up and provide you with the amount of fees that are due.

Your project can begin once the fees are paid and the permit is picked up.

The Permit must be posted in a visible location on the property.


Three days prior to any digging, you must place a PA-1 Call to 811 to have all utility lines marked.

# Requirements for contractors and the rights of homeowners:

The Commonwealth of Pennsylvania requires various contractors performing home improvement to be registered with the Attorney General's office. Besides the registration requirement, there are regulations affecting contracts, the duties of contractors, and the rights of homeowners. 	Ordinance #	Description
1	20-104.4c	Trash cans should be put out no sooner than 24 hours before pickup and should be removed from street no more than 24 hours after pickup
2	10-302	It is unlawful to maintain a motor vehicle that is in disrepair on property.
3	23-101-105	A permit is mandatory prior to work on a pool. Pools must be at least 8 feet from the side or rear lot lines and structures. Fences are required for all in-ground pools and above-ground pools with a height of 4 feet or less. There are also proper barrier requirements.
4	Intl Fire Code 307.4.3	Portable outdoor fireplaces must be at least 15 feet from any structure or combustible material. Exception: 1 & 2 family dwellings. Only seasoned hardwood may be burned.
5	Intl Fire Code 308.3.1	Open-flame cooking devices cannot be used on combustible balconies or within 10 feet of combustible construction. Exception: 1 & 2 family dwellings; or where building/balcony is protected by sprinkler.
6	2-301	Do not allow pet on others' property. Clean up after pet.
7	2-102	Do not allow pet to run at large in the neighborhood.
8	25-108	All trimming and pruning of shade trees shall be done in a manner to ensure natural growth and a natural appearance. Dead branches over 2 inches in diameter should be removed.
9	27-2101	Fences cannot exceed 4 feet in front of property; 6 feet on side & rear of property.
10	10-101-a	Do not blow grass onto neighbors' property or street. Grass must be maintained at 6 inches or less.
11	27-2106.4	Outbuildings must be at least 3 feet from property line, 5 feet from alley, 10 feet from house, and cannot exceed 15 feet in height.
12	25-108	Tree branch clearance must be maintained at 14 feet above street surface and 8 feet above sidewalks.

# **Public Works Department**

### FALL 2019 LEAF COLLECTION SCHEDULE

<u>Beginning November 4</u>: Leaves will be collected from even-numbered address side of the street on the day following trash collection.

<u>On the following week, beginning November 11</u>: Odd-numbered side leaves will be collected. The even and odd sides pattern will continue throughout the fall.

Leaf collection will end on December 27.

### Please note the following changes for leaf collection:

- The Public Works Department will no longer double back for leaves that were not ready for collection.
- Public Works employees will no longer rake out leaves from yards. Leaves must be placed along the curb for collection.

### Follow these guidelines for leaf collection:

- Remove cars from scheduled streets leaves under or around vehicles will not be removed
- We will not provide special pick-ups as a result of conflicts with your landscaper.
- Do not mix branches, grass, rocks, or garbage with leaves.
- Leaves must be placed in front of your home; our new equipment is too large to safely fit down alleys.

Residents requiring leaf disposal prior to November 4th are encouraged to drop them off at Susquehanna Township's compost facility, "Dig My Earth" located at 200 Fort Hunter Road Harrisburg, PA. 17110

### SNOW REMOVAL

As another winter season approaches, the Susquehanna Township Public Works Department has some reminders:

- · Clearing around mailboxes is the homeowner's responsibility.
- Wait for the snow plow to pass before clearing mailboxes and driveways.
- Do not place snow or any other obstruction on the roadway.
- A path should be cleared around fire hydrants.

# Goals and Benefits of STA's Stormwater Management Program

Township residents and businesses will benefit from the enhanced operation and maintenance of a stormwater infrastructure that controls pollution and reduces flooding. The goals of the STA's Stormwater Management Program include:

- Improve local water quality.
- · Comply with the increased state permit requirements for the proper operation of the system.
- Enhance operation and maintenance of stormwater assets in order to save money by extending their useful life.
- Assess the condition of the existing infrastructure to make sure it meets current and future needs and strategically implement improvements in the most cost-effective manner.
- Develop a dedicated and reliable funding source outside the common tax base.
- Implement a fair and equitable allocation of costs to property owners in the Township.
- Educate the community on proper stormwater management, including techniques and practices to assist property owners with minimizing the quantity of stormwater runoff leaving their property.



# Plant a Tree for Your Grandchildren



The effects of environmental degradation and climate change are right on the doorstep of our township. We wheeze from the vehicle exhaust wafting from the highways that traverse our neighborhoods. Increasingly frequent severe storms cause flash floods that imperil life and property. Rising temperatures bring ever more sticker shock to our cooling bills. Wouldn't

it be great if somebody would do something about these dreadful problems?

Great news! You are the "somebody" who can help! No. we're not trying to talk you into meatless Mondays or trading your SUV for a hybrid. The solution is much guicker and easier than that: Just plant a tree! While you're at it, plant two trees! As you're tamping down the last clump of soil around those saplings, you can take pride in knowing that each mature tree will:

- Remove 48 pounds of planet-warming CO2 each year.
- Intercept and filter 70 cubic meters of stormwater runoff. (That's about 18,760 gallons that does not have to be handled by the township's infrastructure.)
- Remove 34 pounds of harmful particulates each year.
- Provide evaporative cooling that is equivalent to the effect of ten room-size, residential air conditioners operating 20 hours a day.
- Cut your air-conditioning costs by 20-50%, if the tree is shading your home.

- Possibly reduce winter heating costs 10-15%, if your trees form a windbreak.
- Decrease your greenhouse gas emissions owing to decreased energy consumption for heating and cooling.
- Provide a home for birds and tree frogs.
- Reduce the need for pesticides (that ultimately end up in our waterways) as the birds and frogs feed on harmful insects.
- Add value to your home by as much as 5 to 20 percent.

In short, trees buffer against environmental threats and provide an astounding return on your investment. For a few hundred dollars, you can reduce pollution, help fight climate change, and increase the value of your home. No single action on your part can have as great and long-lasting a benefit for yourself and for our township. Moreover, you can leave no greater legacy for your grandchildren than a cleaner, greener world. Show your love and grow your love by planting trees!


Monday through Friday. Like the Day Camp, playgrounds also receive a free lunch daily except for Wednesdays when they are on their field trips.






