- 5. Any damage, defacement, or removal of park property will be prosecuted to the fullest extent of the law.
- 6. All concessions must have the written permission of the Township Manager.
- 7. Return payment; payable to Susquehanna Township Recreation, 1900 Linglestown Road, Harrisburg, Pa. 17110, along with this completed form to receive confirmation of reservation by permit.
- 8. Park hours are dawn to dusk, except Veterans Memorial Park when lights are used on athletic facilities an eleven o'clock (11:00) pm curfew is observed.
- 9. Verify the accuracy of the information shown on this form and that you will abide by all rules, regulations and Ordinances by signing below where indicated.
- 10. All claims are waived against the Susquehanna Township Parks & Recreation Department and Susquehanna Township for any personal injury or death, which may occur, unless negligence is involved.
