## RESOLUTION NO. 2019 - 08

A RESOLUTION OF THE SUSQUEHANNA TOWNSHIP AUTHORITY, DAUPHIN COUNTY, PENNSYLVANIA, FORMALLY REQUESTING AN H2O PA GRANT FROM THE COMMONWEALTH FINANCING AUTHORITY FOR THE SOUTHERN AREA SANITARY SEWER EXTENSION AND DESIGNATING AN OFFICIAL TO EXECUTE ALL DOCUMENTS AND TO FACILITATE AND ASSIST IN OBTAINING THE REQUESTED GRANT.

WHEREAS, the Susquehanna Township Authority, Dauphin County, Pennsylvania, owns and operates wastewater collection and treatment facilities under WQM Permit No. WQG 02221802 and,

WHEREAS, modifications and improvements to the system are necessary in order to comply with the requirements of said Permit and requirements of the approved Susquehanna Township Act 537 Plan.

NOW, THEREFORE, Be It Resolved, and it is hereby Resolved, that the Susquehanna Township Authority, Dauphin County PA (Authority) hereby request an H20 PA grant of \$1,770,000 from the Commonwealth Financing Authority to be used for upgrading, modifying and improving the Authority's wastewater facilities to comply with the requirements of the aforementioned WQM Permit and 537 Plan. The Authority shall provide matching funds in an amount equal to the said grant request.

BE IT FURTHER RESOLVED, that the Authority does hereby designate Anthony Salomone (Chairman) and Yves Pollart (Secretary) as the officials to execute all documents and agreements between the Township and the Commonwealth Financing Authority to facilitate and assist in obtaining the requested grant.
