## GRADING/EXCAVATION PERMIT

Permits are required for any excavation, grading, or fill for areas over 25 cubic yards (25 square feet) of disturbance, not including trenching for utilities, or if the work is being done for the purpose of immediate construction of a building or improvement for which a building permit has been issued, if, in the opinion of the Code Official evidenced, in writing, on such building permit, no hazard to property rights of the Township or adjoining land owners will be encountered or created by such excavation or fill. This permit is separate from any stormwater management permits, which are required for over 1,000 sqft of disturbance.

*The application must be complete in all sections. Print must be legible. Submit two (2) sets of plans with your completed application, including the site plan. All grading plans should show the existing contours at two-foot intervals of the area involved and the proposed final contours for grade. Erosion and Sediment Control Devices shall be utilized for all activities which exceed 100 sqft. An Erosion and Sediment Control Plan must be submitted for plans that exceed 5,000 sqft of earth disturbance along with the Dauphin County Conservation District E&S Control Plan Review approval letter.*
