Susquehanna Township Has Gone Solar!!

Susquehanna Township has completed installation of a solar electrical system that will provide 85% of the electricity needed by the township administration, police, emergency services and highway maintenance buildings. Through an agreement with Solar Renewable Energy LLC, the solar panels are being installed at no cost to the Township and they, along with energy efficiency improvements, will immediately lower the Township's electric bills. In addition, the roof of the Administration Building was replaced as part of the deal, also at no cost to the Township!

This effort is in keeping with our strategic plan for a Sustainable Susquehanna as we look forward to building a better future for all our residents. The system has a life expectancy of 40 years and is projected to save the township over \$1 million by locking in our electric rate for that period, while also reducing our carbon footprint. The system became fully operational at the end of April 2020.

EVERYONE COUNTS!!!! Census 2020

By now every household should have received a census questionnaire in the mail. Beginning May 13, any household that did not respond to the census questionnaire, (by mail, online, or via phone) will be contacted by a census taker. Your response matters!

Here are some quick stats about the census:

- The census occurs every 10 years
- It counts every person living in the US and its territories – once and only once
- It takes approximately 10 minutes to complete
- All responses are safe, secure, and protected by federal law

Census data is used for the following:

- To decide how \$675 billion in federal funding is spent every year for healthcare, roads, community development and other programs
- To determine the number of US Representatives each state will have
- To redraw US congressional, state, and local legislative districts

Grading Permit

Are you digging or adding fill to your property? If so, a grading permit may be required.

A grading permit is required for the following activities:

- A change in drainage (if under 1,000 square feet)
- A total volume of disturbance greater than 25 cubic yards

This permit is separate from any stormwater management permits, which are required for over 1,000 square feet of disturbance. Property cannot be graded to release water onto adjacent properties.



Occupancy Report Permit

Do you own property in Susquehanna Township, but rent it out? If so, you are required to complete a Status of Occupancy Report each time a tenant moves into or moves out of your property. Within 10 days of an occupancy change, the form must be submitted to the Township. More information can be found at www.susquehannatwp.com/rental.

Building Codes and Permits

Thinking of remodeling or adding an addition to your home? The Susquehanna Township Community Development Department can help you navigate your way through.



Steps for applying for a permit:

1. Determine if the project requires a permit:

Permits are not required for: painting, installing cabinets, flooring, installing new siding material, gutters, downspouts, replacement windows/ doors (in the same opening if the framing is not altered), installation of additional rolled or batt insulation, replacement of existing electrical devices with approved devices, communication wiring and/or wireless devices, repairs to plumbing leaks not requiring structural changes, replacing an existing faucet or sink, clearances of stoppages and replacement of existing appliances.

2. If a permit(s) is required, things to consider:

- The type of project determines whether approval is required under the Building Code, Zoning Ordinance, Health Code or all three. **Township staff should be consulted in the planning stage to determine the permit requirements.**
- Projects that do not require building permits may require zoning permits. These projects would include fences, certain accessory structures under a certain size, new or expanded driveways, gazebos, etc.
- Some projects may require separate electrical and plumbing permits.
- A permit to convert from one heating source to another requires a permit. The manufacturer's installation and operation specifications must be submitted with the permit application.
- The installation of solar panels on a roof requires a structural engineer to provide verification that the roof can support said additional loading. Electrical plans are required as well.
- Please take note that the State Legislature has adopted the 2015 Codes with amendments on October 1, 2018 to the Uniform Construction Code (UCC). Information can be found on the Labor and Industry website www.dli.state.pa.us under the Uniform Construction Code section.

3. Obtain the applicable permit application(s) at the Township Building or online at: www.susquehannatwp.com.

4. Submit a completed application to the Township Office.

- A completed application includes two sets of complete plans (Residential plans must be a minimum of 11" x 17" in size) including specifications and a plot (site) plan.

5. Application will be reviewed by Township Staff. Reviews can take up to 15 business days, so plan accordingly.

- Projects may also require approval under provisions of other Township Ordinances and State requirements.
- Residential plan review and inspections (except for electrical) are performed by the Building and Zoning Office. Certified Third-party Inspection Agencies perform electrical plan review and inspections.
- Projects requiring variances or special exceptions from the Zoning Hearing Board must receive approval.
- Fees are determined based on the total construction cost of a project. The Township determines the fees.
- NOTE: If other approvals are required, these are separate from the building permit review and should be taken into consideration when planning a project. These approvals must be in place prior to submission. In most cases, all approvals must be obtained in order for building, electrical, and plumbing permits to be issued for a project.

6. Permit is issued

- The Township will contact you when your permit is ready to be picked up and provide you with the amount of fees that are due.
- Your project can begin once the fees are paid and the permit is picked up.
- The Permit must be posted in a visible location on the property.
- **3 days prior to any digging, you must place a PA-1 Call to 811 to have all utility lines marked.**

Requirements for contractors and the rights of homeowners:

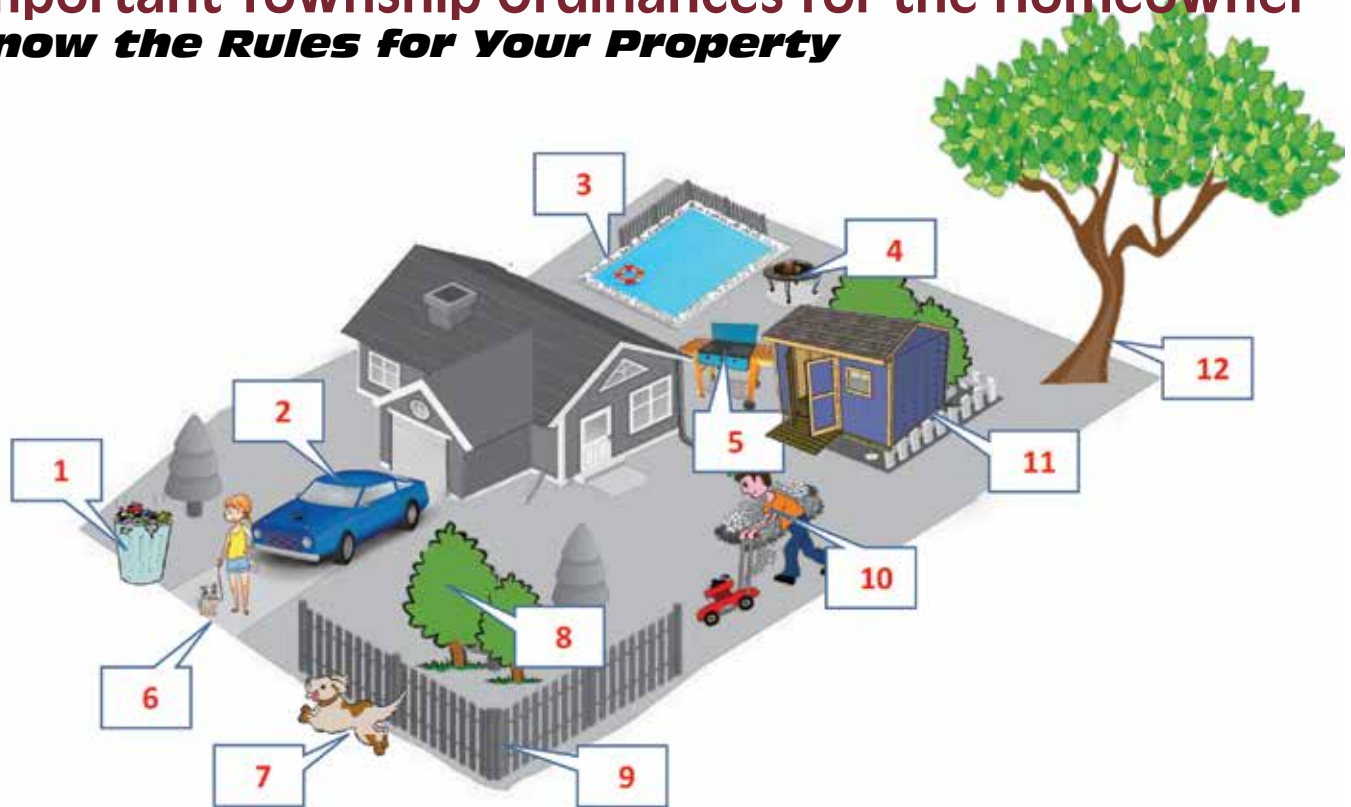
The Commonwealth of Pennsylvania requires various contractors performing home improvement to be registered with the Attorney General's office. Besides the registration requirement, there are regulations affecting contracts, the duties of contractors, and the rights of homeowners. Important Township Ordinances for the Homeowner

Know the Rules for Your Property



Ordinance #		Description
1	20-104.4c	Trash cans should be put out no sooner than 24 hours before pickup and should be removed from street no more than 24 hours after pickup.
2	10-302	It is unlawful to maintain a motor vehicle that is in disrepair on property.
3	23-101-105	A permit is mandatory prior to work on a pool. Pools must be at least 8 feet from the side or rear lot lines and structures. Fences are required for all in-ground pools and above-ground pools with a height of 4 feet or less. There are also proper barrier requirements.
4	Intl Fire Code 307.4.3	Portable outdoor fireplaces must be at least 15 feet from any structure or combustible material. Exception: 1 & 2 family dwellings. Only seasoned hardwood may be burned.
5	Intl Fire Code 308.3.1	Open-flame cooking devices cannot be used on combustible balconies or within 10 feet of combustible construction. Exception: 1 & 2 family dwellings; or where building/balcony is protected by sprinkler.
6	2-301	Do not allow pet on others' property. Clean up after pet.
7	2-102	Do not allow pet to run at large in the neighborhood.
8	25-108	All trimming and pruning of shade trees shall be done in a manner to ensure natural growth and a natural appearance. Dead branches over 2 inches in diameter should be removed.
9	27-2101	Fences cannot exceed 4 feet in front of property; 6 feet on side & rear of property.
10	10-101-a	Do not blow grass onto neighbors' property or street. Grass must be maintained at 6 inches or less.
11	27-2106.4	Outbuildings must be at least 3 feet from property line, 5 feet from alley, 10 feet from house, and cannot exceed 15 feet in height.
12	25-108	Tree branch clearance must be maintained at 14 feet above street surface and 8 feet above sidewalks.

Tips for Driving Safely in Road Construction Zones

Summer road construction season is here, and all motorists need to be alert! Whether you've been driving for decades or got your driver's license last week, the tips below are important reminders to make sure you and road construction workers get home safely.

- Expect the unexpected in road construction zones.
- Slow down, be alert and pay attention to the signs.
- Comply with the directions given by the flagger.
- Be patient in road construction zones.
- Drive defensively — don't follow too close.
- Obey the posted signs until you see the ones that say you've left the work zone.
- Expect delays; plan for them and leave early to reach your destination on time

Stormwater Fee Update

On February 4, 2020, the Susquehanna Township Authority (STA) authorized the implementation of a stormwater utility fee for all properties in the Township. A stormwater fee is an assessment of the amount of stormwater runoff from an individual property. As a result of the COVID-19 pandemic, customers can now expect to see the Stormwater Fee bill at the end of July 2020. Some quick facts about the fee:






Fee structure:

- The fee is based on impervious area (IA), such as asphalt, concrete, and buildings.
- There is an appeal process and credit policy in place.
- The fee will allow the STA to equitably distribute the costs of stormwater management services.
- The fee will be billed through the STA on a quarterly basis.
- All property owners will receive a bill, even for land without any impervious area.
- All revenue collected will be used solely for the administration, operation, management, and improvement of STA's stormwater facilities and our local waterways.

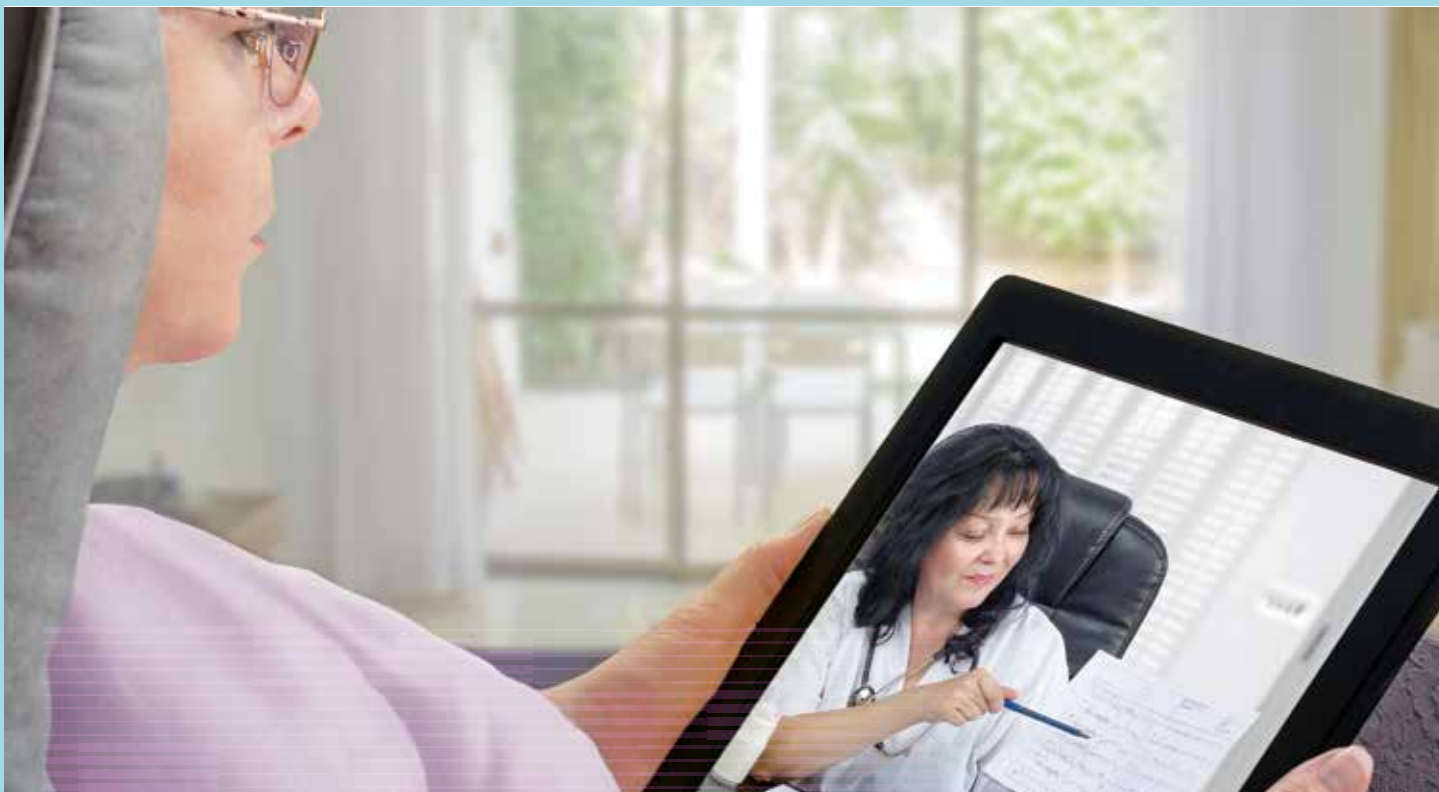
