REPORTS OF AUTHORITY STAFF

Manager/Director of Finance

Written report submitted for the month of August 2021. Ms. Lovett noted there were 35 permits issued in the month of August of which 31 were in the Southeast Sewer Extension.

Mr. Pollart questioned if the purchase of the ATV was approved by the Board of Commissioners. It was approved at the Township's Commissioners' last meeting and the purchase will take place.

Stormwater report for the month of August 2021 attached. Ms. Smith noted that the stormwater work being done in Shutt Mill Park will be split evenly with PennDOT. Each project will be approved and signed separately.

Mr. Laskowski reported that Fulton Bank had the Wedgewood property appraised. Fulton will be discussing items with their solicitor who will be relaying Fulton's decision to Mr. Laskowski.

Mr. Laskowski stated he had proposed language for the amendment to the Authority By-laws regarding Mr. Laskowski suggested the electronic meetings. Board amend the by-laws include to telecommunications in a disaster or emergency. Mr. Laskowski believes that four (4) Board Members must be physically present for meetings even with a telecommunications presence, but at the discretion of the Chair, in an emergency, a quorum could be established completely through electronic communications.

<u>Spring Creek Drainage Basin – SE Extension</u> – Mr. Kostelac stated that ninety percent (90%) of the mainline sewer installation is complete. RIII has agreed to reduce their change order for pipe costs to a 25/75 split with the Authority with the Authority paying 75% of the requested Change Order. This would reduce the Change Order amount from \$15,720.00 to \$11,790.00. Mr. Kostelac recommended approval for Change Order No. 1. Mr. Sanderson motioned to approve payment of Change Order No. 1 in the amount of \$11.790.00. Mr. Napper seconded, and the motion was approved unanimously. Kostelac recommended approval of payment of Application No. 10 in the amount of \$229,576.53 for the Southeastern Sanitary Sewer Extension Project. Mr. Sanderson motioned to approve Application No. 10 in the amount of \$229,576.53, Mr. Ward seconded, and the motion was approved unanimously.

Enclave at Elmerton – 2101 Elmerton Avenue - Mr. Kostelac stated GHD had reviewed the planning module and recommends approval by the Board. Mr. Ward motioned to approve the Enclave at Elmerton planning module, Mr. Sanderson seconded the motion, and the motion was approved unanimously.

This is located within the Spring Creek basin which is not under Corrective Action connection restriction. Mr. Kostelac stated GHD has prepared a letter indicating the Ability to Serve the project and recommends Board approval and signature of the exemption request. Mr. Sanderson motioned to approve the Tommy Carwash, Mr. Ward seconded the motion, and the motion was approved unanimously.

Hero's Grove – 5000 Commons Drive (Lower Paxton Township) – Mr. Kostelac stated GHD had reviewed the planning module and recommends approval by the Board. Mr. Sanderson motioned to approve the Hero's Grove planning module, Mr. Ward seconded the motion, and the motion was approved unanimously.
